Survey Findings

- Little policy work initiated
- Many expressed desire to get more involved
- Demonstrated need for training and orientation for LBOH members
- Knowledge of public health issues associated with more involvement in public health policy

Roles and Responsibilities of a Local Board of Health Member - General Introduction

As a member of the Local Board of Health, this section of your orientation will acquaint you with your role, responsibilities, and authority. You are now a member of the governing board in your county or district which has been given the "jurisdiction over public health matters".

First, you will become acquainted with your role in complying with your legal responsibilities. This section will introduce you to the Iowa Codes and the Iowa Administrative Codes (IAC) that are specific to the local boards of health. This will include learning about the proper conduct of open meetings, the legal issues of providing public health services, and the powers of the board of health.

You will study how the local board of health has an active role in determining what the public health needs are in your community, and evaluating whether current services meet these needs.

You will also learn about your role regarding fiscal oversight for public health in your county or district. This includes setting goals and priorities, determining how public health will be provided in your community, and ensuring that the services that are provided are effectively and efficiently using resources.

The Code of Iowa is the law of the State of Iowa. The Code of Iowa is created and adopted through legislative process. Once a bill is introduced, it must go through a series of events before becoming law.

A. Legal Resources

1. List of all Iowa Code sections which make reference to a "Local Board of Health" or "County Board of Health"

This document was created to bring together all of the different instances in Iowa Code in which local public health is mentioned.

2. Tort Liability: Code of Iowa, Chapter 670

This statute discusses financial and legal issues related to local boards of health. Topics included in this chapter of Iowa Code include definitions, insurance, legal settlements, taxes, and what to do in case of judgments in Iowa courts that are against the local board of health.

3. A Bakers Dozen - 13 Issues Regarding the Open Meeting Law

This PowerPoint presentation summarizes the details of the Open Meeting Law, and explains which governmental bodies are covered by the law. This presentation is an excellent introduction for individuals who do not have a background in law, or are new to public health or the local board of health system in Iowa. It may be too basic for seasoned members of local boards of health.

4. Iowa Attorney General Sunshine Advisories (relate to Iowa Code Sections 21 and 22)

The Iowa Attorney General's Office has issued monthly "Sunshine Advisory" bulletins since November 2001. The Advisories discuss basic requirements and application of Iowa's Open Meetings Law and Public Records Law (Chapter 21 and Chapter 22 of the Iowa Code).


